This deed made this 11th March 1871. Between
Mary Hickson Administr^{trix} of Tho^s. Hickson de^{ce}.
Acting under the provisions of said Hickson's
Will of the one part; and N. E. Warren
of the other part: Witnesseth: That for & in
Consideration of One Hundred Dollars paid by
the said N. E. Warren the said Mary Hickson
doth grant with general Warranty to the
said N. E. Warren the following
part of Lot No 36 in the Town of Farmville
in Subdiv^{ision} Randolph Survey; lying on 3rd
Street, it being a vacant lot mentioned in the
said Tho^s. Hickson's Will, the line beginning
at lot No 37 & running West 55 feet to near the end
of the store House, belonging to Hickson's Estate, then
North along N. E. Venable's line to line of Lot recently
belonging to S. O. Southall; thence East to the line
of Lot No 37, thence along said line about 50
feet to 3rd Street at the beginning as per Plat

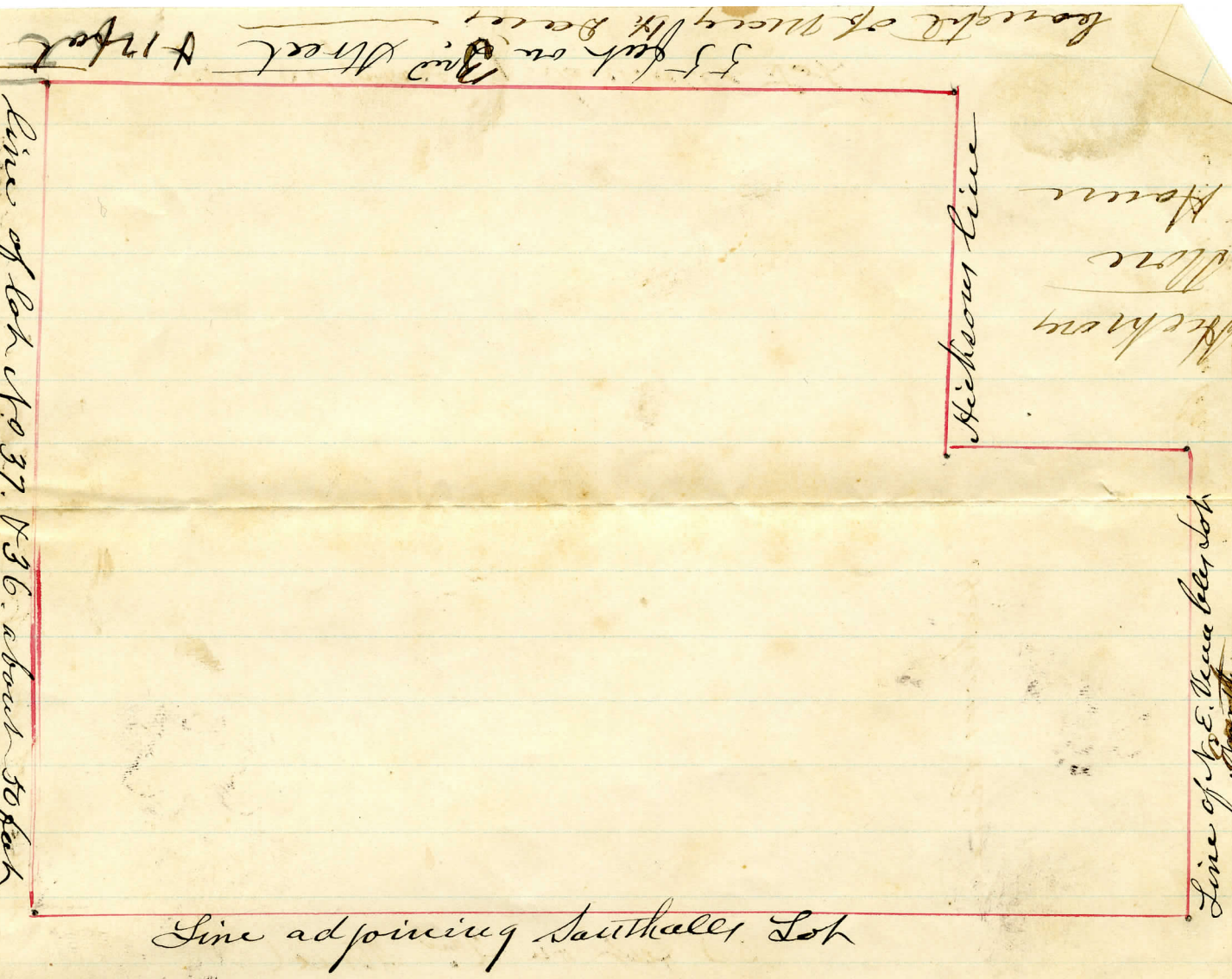
