In celebration of Black History Month, the Farmville-Prince Edward County Historical Society will be hosting a presentation by Library of Virginia Archivist Greg Crawford. Mr. Crawford will speak about the Virginia Untold project, which provides greater accessibility to African American history and genealogy contained in Library of Virginia collections. This project includes digitizing thousands of records, dating from the 1600s through 1865, that pertain to African Americans both enslaved and free in the State of Virginia.

On February 3, 1943, Farmville's own Company G was mobilized for service in World War II.
Tucker Doyne, then proprietor of Farmville's Doyne-Burger Funeral Home, was a prolific scrapbooker and during World War II compiled a scrapbook filled with newspaper clippings and photographs of

members of the 116th Infantry's Company G. These include notifications of servicemen injured or killed in battle while serving on the European front.
