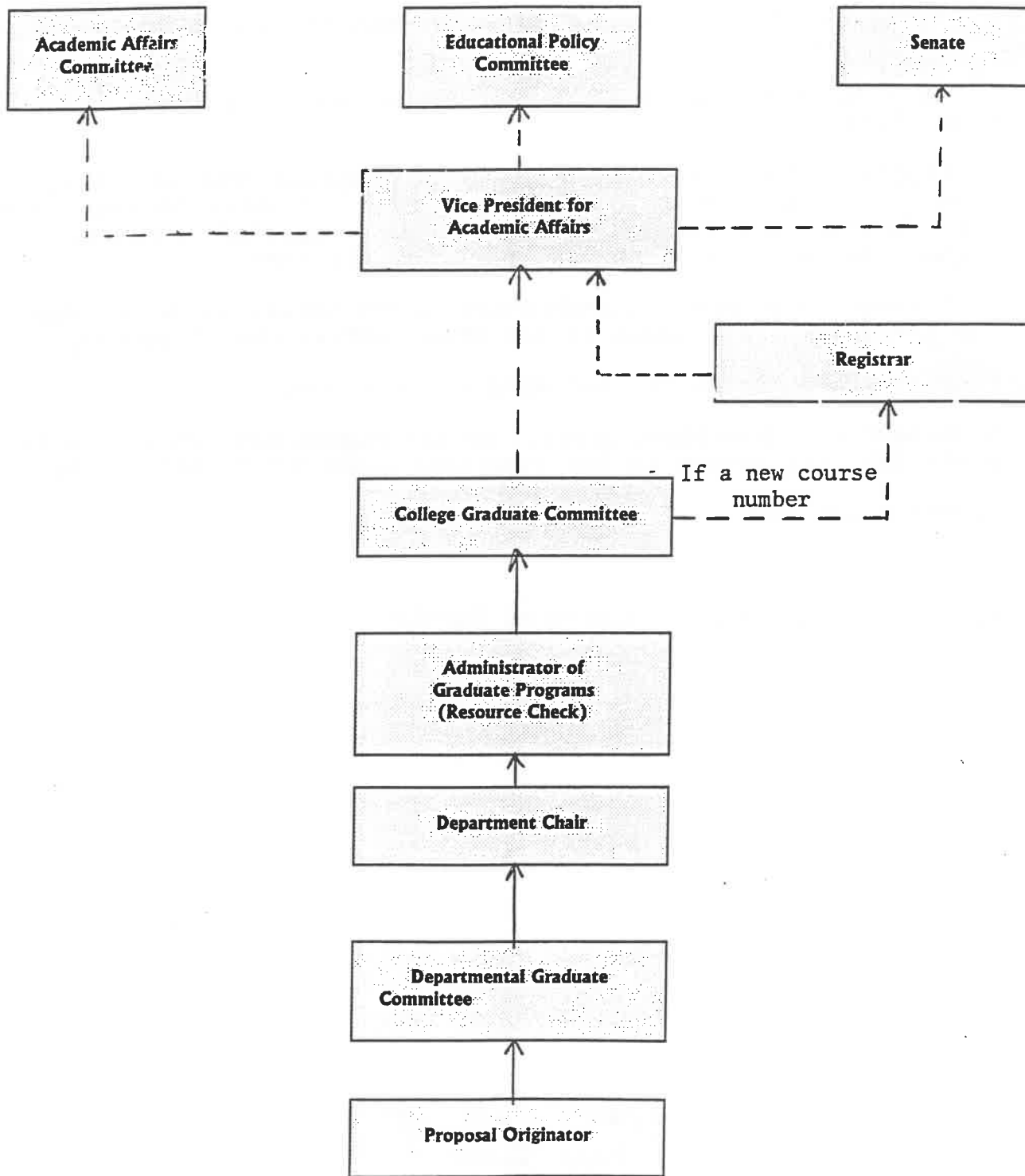

Introduction of a New Graduate Course

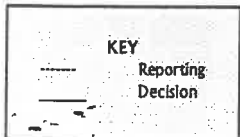
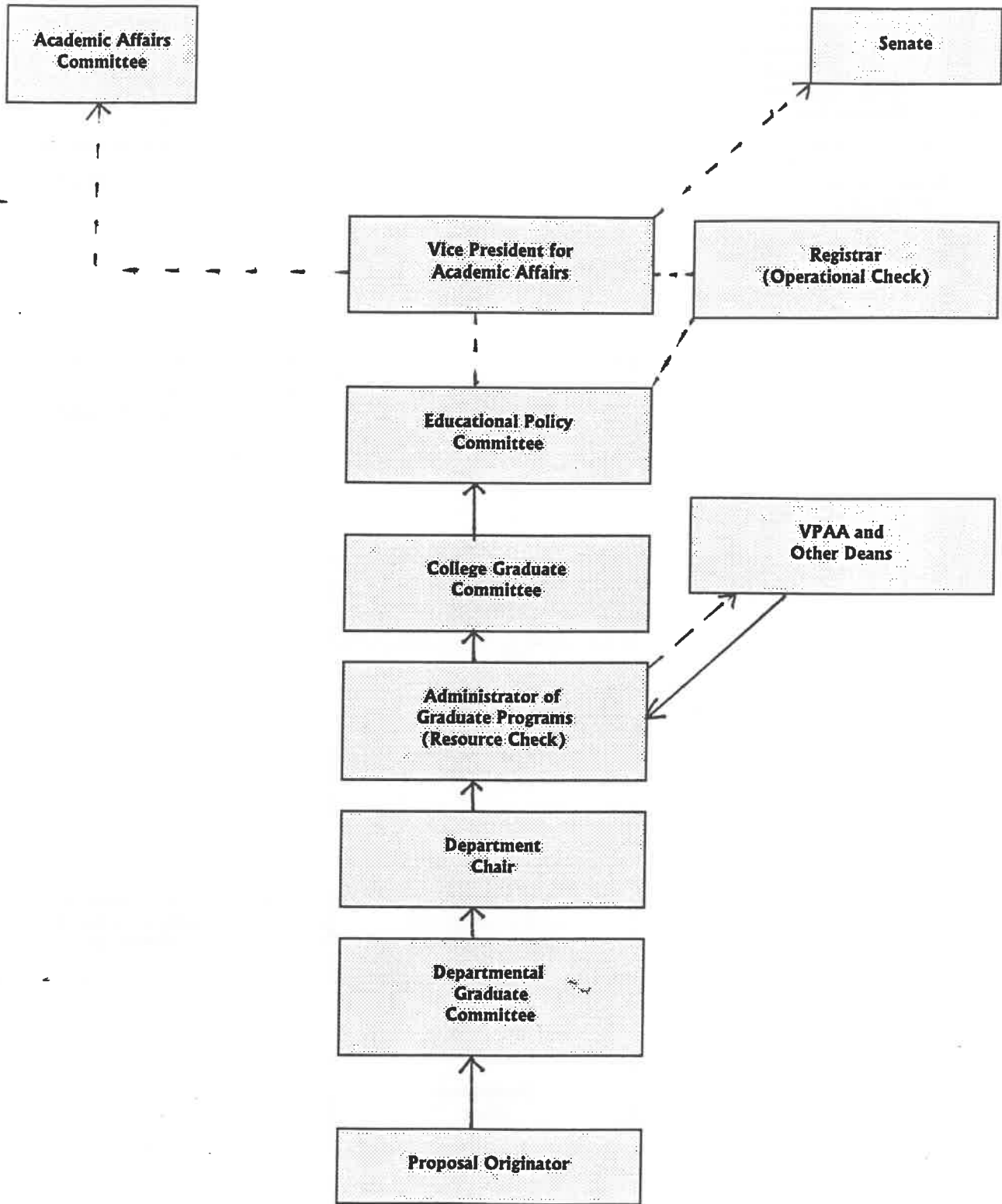
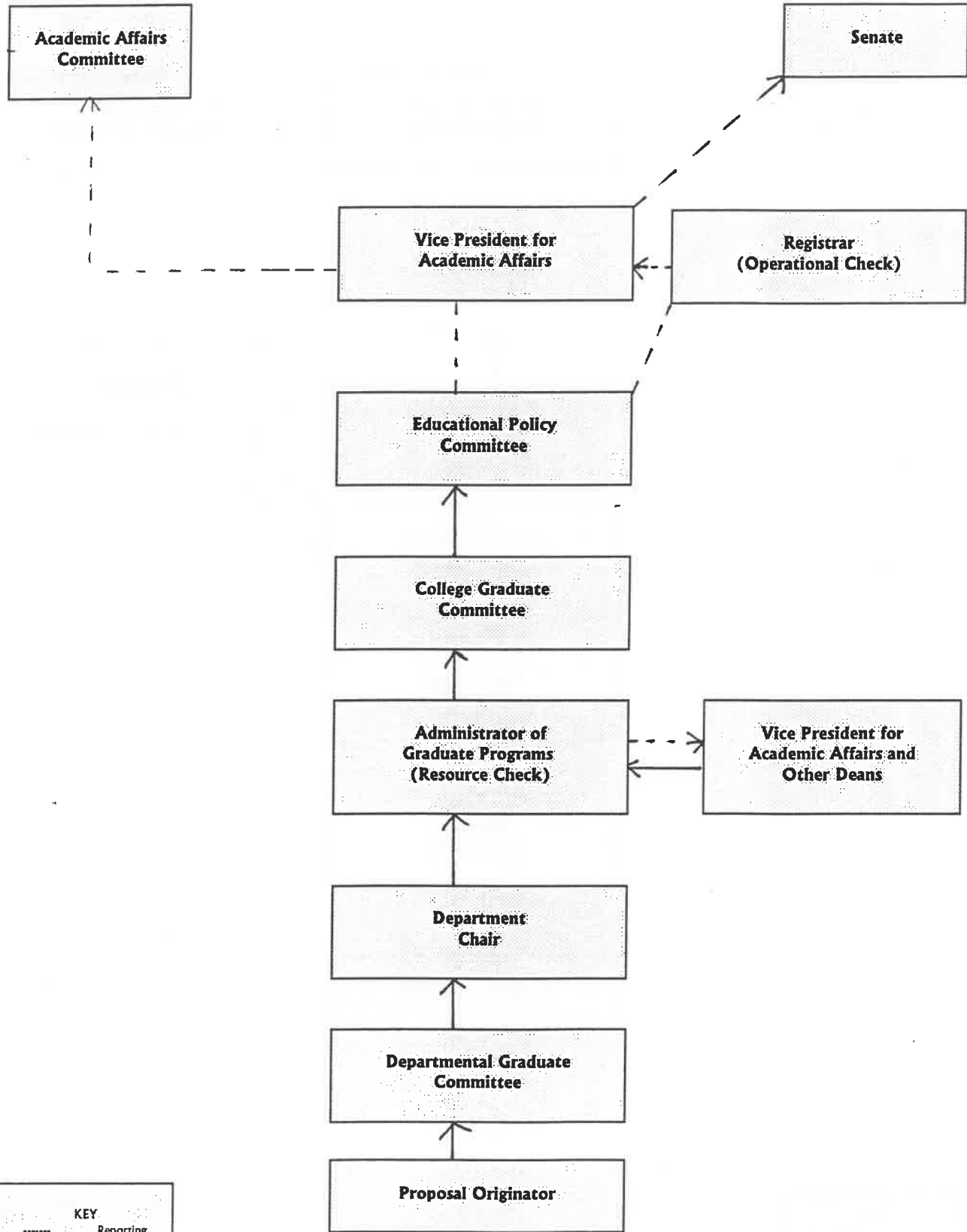

Changes in Requirements Within a Graduate Program: A Major, Minor, Concentration or Licensure

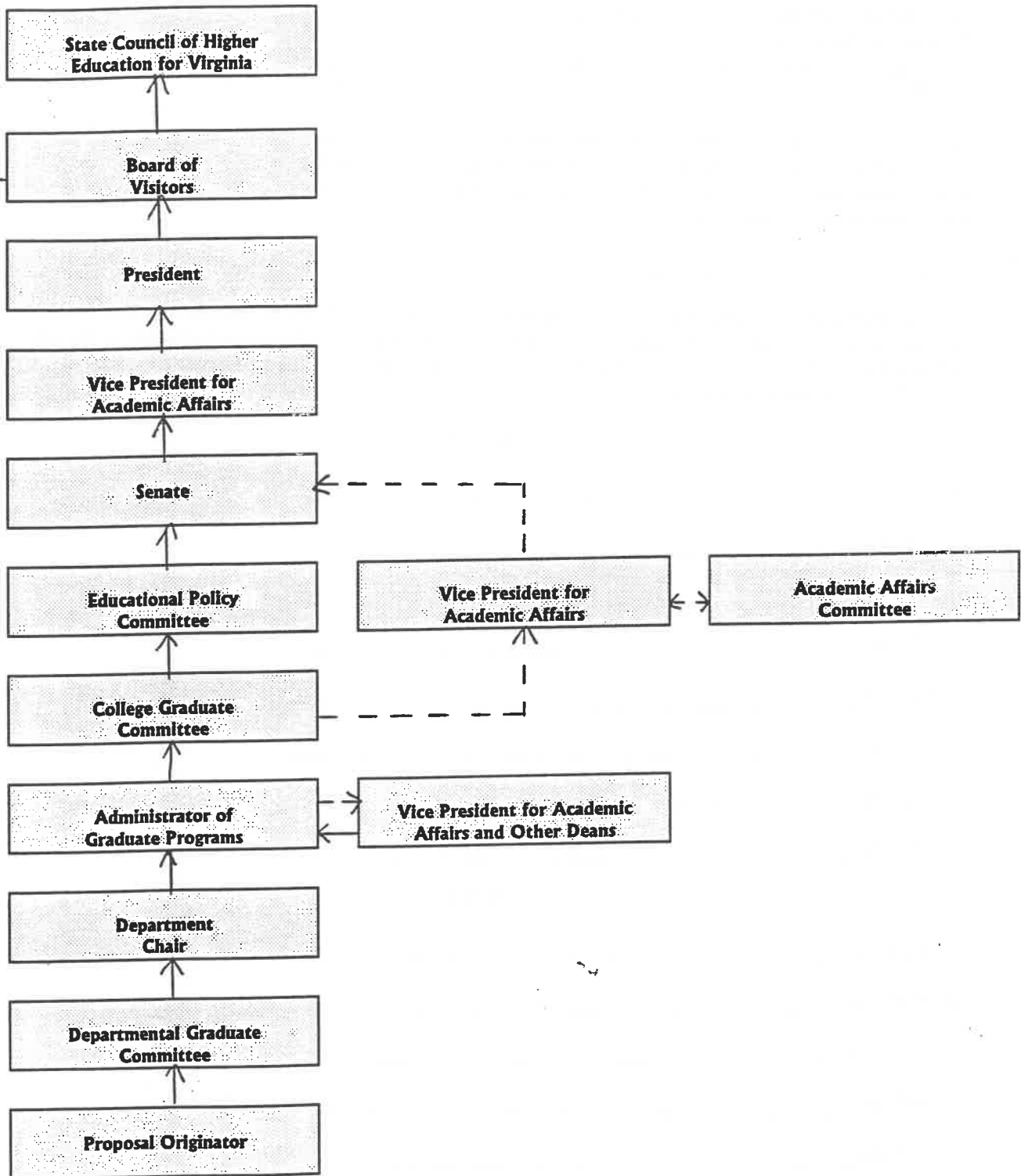
