### Shana Interview

Leonie Verstrate: Leonie Verstrate but I go by Lulu here.

Molly Craig: I'm Molly.

Shana: Hi.

LV: Thanks, first of all how's your day going?

LV: Okay good, I guess we are going to start the interview.

LL: We have to state our names, so now we are going to state our names and location. I'm Lauren Layman, it's November 7<sup>th</sup> and we are at Prospect Volunteer Fire Department.

JC: I'm James Cox, today's November 7<sup>th</sup> and we are at Prospect Fire Department.

MC: How long have you been in the area?

S: I guess this Harvest sale, it's been going on for years but I've only been participating in it for 8 years, but it brings the community together so....

LV: Can you explain us what Harvest Sale is?

S: they just have an auction sale from all the people around that just donate different things and we have a bake sale and a dinner in the afternoon.
