


In Consideration of the fact that we are
justly indebted to Paulett Son & Co in the sum
of Four Hundred & Ninety Five ~~74100~~ Dollars
for Hunt and Supplies furnished us in the
present year for Hunt for 175.⁰⁰ and for Supplies
Guano &c for which we executed Bond for Hunt
and a Crop Line Bond for said Supplies.

Now rather than incur Expense by a levy
which they have a perfect right to do, we
humbly yield Control of the Tobacco now in
Basins and hereby grant the right to said Paulett
to lock all the Basins containing the Tobacco
and have the Tobacco Trucked down and Trip
and Carried to Market & sell the same and
out of net proceeds the above named debt
is first to be paid if enough to pay out the
Indebtedness as above stated if not then they will
fall back on the property secured to them by full
sale which they the said Paulett Son & Co hold


hold against us, & it is understood that whatever amount
may be left from the sale of said Crop of Tobacco
if any after paying the said debt, to said Paul & Co
shall be paid to the ~~same~~ parties signing this
Paper.
