Mr. Mark Baldrige, Drs. Norm Bregman, Bill Burger, David Cordle, Jeffery Peden, and Gordon Van Ness were absent.

Dr. May asked for corrections and additions to the minutes of the December 9, 1999, Faculty Senate Meeting. The minutes were then approved as distributed.

Dr. May then brought forward information about the newly formed Student Affairs Committee on Honor Code Violations Appeals – hearing only appeals concerning academic cheating and plagiarism. The committee members are the Vice President for Student Affairs, a faculty member, and a representative from the Student Government Association. Dr. May, on behalf of the Faculty Senate Executive Committee, moved to ratify the faculty member from each school – Lee Bidwell, Wayne McWee, and Theresa Clark—to serve on the committee. The motion was voted on and carried.

Dr. Flanigan, on behalf of EPC, brought forward the following motion, moving the item from “Information” to “Action”. The updated title of the new degree is “Community Health Education,” not “Public Health Education” as stated on the handout.

Motion #1:

On behalf of EPC, Dr. Flanigan moved for approval of the new degree program “Community Health Education” and the new minor “**Health Education**”. Dean Smith confirmed that there are no resource implications. The motion was voted on and carried.

Motion #3

Add to the Curriculum Handbook, in the General Policies section, "When program changes include new courses, the new courses must be approved prior to, or concurrent with, the program change proposal."

The motion was voted on and carried.

Motion #4

Add to the Curriculum Handbook, on page 7, under responsibilities of EPC Chair, Notify Deans, VPAA, and Senate President of Schedule, "Director of Graduate Studies."

The motion was voted on and carried.

Motion #5

Add to the Curriculum Handbook, on page 18, under New Courses and Course Changes, "Proposers of curriculum changes should be aware that EPC may consider substantive changes in a course to constitute a new course." Note: This refers to changes that do not ordinarily require approval by EPC course title, content, credit hours, number, but may change a course substantially, particularly when changes are made in combination.

English, Philosophy and Modern Language - Change in Journalism minor

- Required credits increased from 9 to 12 credits, electives decreased from 9 to 6;
- Changes in the courses specified - both requirements and electives

Natural Sciences - change in Earth Science Minor

Change in the required number of elective from 4-5 credits to 6 credits. This increases the total credits to 24 and thus aligns the minor with requirements in other science minors.

Speech and Theatre - Change in minor in Theatre

Change in the courses required and change in the total number of credits.

Music - Instrumental Performance Concentration Change

- Delete the requirement for 2 credits of Applied Secondary Voice.
- Reduces the total credits for the Bachelor of Music with a concentration in Performance *from 126 to 124*

Natural Sciences - Changes necessary for teacher endorsements

Biology - Changes:

- For teaching endorsement in Biology *from* students must take SCED 352, and 31 credits (total 34 credits) *to* students must take SCED 352, EASC 300 and 31 credits (total 37 credits)
- Teaching endorsement level changes *from* grades 8-12 *to* grades 6-12
- B.A. in Biology with Secondary Teaching Endorsement *from* 134/135 credits *to* 137/138 credits
- B.S. in Biology with Secondary Teaching Endorsement *from* 131/132 credits *to* 134/135 credits

Chemistry- Changes

- For teaching endorsement in Chemistry *from* students must take SCED 352, and 31 credits (total 34 credits) *to* students must take SCED 352, BIOL 412, EASC 300, and 31 credits (total 41 credits)
- Teaching endorsement level changes *from* grades 8-12 *to* grades 6-12
- Delete 7 credits of general electives for B.A. majors seeking secondary teaching licensure
- B.A. in Chemistry with Secondary Teaching Endorsement remains at 120 credits
- Delete 6 credits of general electives for B.A. majors seeking secondary teaching licensure
- B.S. in Chemistry with Secondary Teaching Endorsement *from* 120 credits *to* 121 credits

Physics - Changes

- For teaching endorsement in Physics *from* students must take SCED 352, and 31 credits (total 34 credits) *to* students must take SCED 352, BIOL 121, EASC 300, and 31 credits (total 41 credits)
- Teaching endorsement level changes *from* grades 8-12 *to* grades 6-12
- B.S. in Physics with Secondary Teaching Endorsement *from* 122/126 credits *to* 129/133 credits

Mathematics - Change in Teaching Endorsement

- Changes catalog description for teaching endorsement including change in levels *from* 8-12 *to* 6-12
- Adds Algebra I Teaching Endorsement (25-26 credits) for grades 6-12

Dr. May then called on Dr. Howe to discuss the recommendations from the P&T Committee. Dr. Howe asked that the item be changed from "Action" to "Information". Senators are asked to discuss at the department level and send feedback to him. The recommendations will be voted on at the February Faculty Senate Meeting.

Much discussion occurred including many suggestions for refinement of terms, clearer procedures, and better wording of policy. Dr. Howe noted feedback received at the meeting and stated that he would get back with the P&T to revise the recommendations.

The meeting was adjourned at 4:40 p.m.
