General Faculty
August 21, 1998

Dr. Howe called the Opening General Faculty Meeting to order at 9:30 a.m. in
the Hull Auditorium.

Minutes of the August 18, 1997 meeting of the general faculty were approved as
distributed.

An announcement was made that Dr. Ray Brastow is the chair of the Faculty
Status Committee for this academic year. Dr. Bob May was elected by
acclamation to serve as the representative to the Faculty Senate of Virginia.
Dr. Craig Challender was elected by acclamation to serve as Faculty
Representative to the Board of Visitors for the 1998-99 academic year.

Vice President Norm Bregman gave an update on the state of academic affairs to
the faculty. He also announced the changes in administrative duties for some
of the faculty. Dr. Bregman then introduced Deans Farmer and Smith who
introduced the new faculty in each of their schools. Dr. Cordle called on the
chairs of the LAS School departments to introduce their new faculty.

Dr. Howe announced that the first meeting of the Faculty Senate would take
place on September 3 instead of September 10 due to Convocation on the 10th.

The meeting adjourned at 11:00 a.m.
