Dr. Lily Goetz, Mr. David Harnage, Dr. Tim Pierson, and Dr. Gordon Van Ness were absent. Ms. Alecia Knox, Dr. Nancy Krippel, Dr. Ed Smith, and Mr. Billy Magyar were also present.

The minutes of the November 8, 2001, meeting of the Faculty Senate were approved as distributed.

Dr. Burger reported the following information items from the Educational Policies Committee:

1. Department of Music
 - a. Change name of Musc 202/404 (section 3) from Flute Choir to Flute Ensemble
 - b. Change name of Musc 202/402 (section 21) from Concert Band to Wind Symphony
2. Natural Science Department: Delete Biol. 352 from the Catalog.
(also offered as SCED 352)
3. Program change from EPML department: Reduce French, German and Spanish 461, Senior Seminar, from 3 to 2 credits. Add one hour of Directed Study to Major requirements. These two must be taken together. No Change in the number of required credits.
4. Changes in Mathematics major:
 - a. Require Philosophy 300 for goal 12
 - b. Require Math 350 goal 13.
 - c. Require (at least) a 1-credit internship, directed study, or field experience.
5. Sociology:
 - a. Delete soc.201
 - b. Drop concentration in Criminal Justice (replaced by the recently approved Major)
6. Department of HPRED program changes:
 - a. Athletic Training Concentration
 1. deletion of Phed 116, any of the existing aquatics course and HLth205
 2. Addition of Phil 315 and a three hundred level psychology course currently the course is a 200 level which will be a three hundred course next year.
 3. Revamping of Phed 210,320 and 325. Renaming and revamping of Phed 371, 372, 471,472 and 473. Also increasing the number of hours from 1 to 2.
 4. Reducing the number of prerequisites for Phed 320 and 325.

- b. Exercise Science Concentration
 - 1. deletion of Mark 380 replaced by Hlth 415
 - 2. requiring Chem 111 or Chem 101
 - 3. Add an already existing class phed 216.
- c. Community Health Education
 - 1. add hlth 495 Special Topics Current Topics in the filed that may or may not change yearly.
 - 2. Psy 384 for goal 12
 - 3. Phil 315 for goal 13
 - 4. delete hlth 375
 - 5. hlth 215 add prerequisite phed 101
 - 6. hlth 313 remove prerequisite biol 207
 - 7. hlth 315 and 415 remove prerequisite hlth 375

 - a. Recr 237 name change of the course.
 - b. Recr 238 reduce credits from 3 to 2.
 - c. Cdis 462 add Cdis 375 as additional prerequisite for 462
 - d. Educ 489 change name to SPED 489
- 8. EDHS School Curriculum Committee Information Items
 - a. Cdis 290 Change to Cdis 390
 - b. Change prerequisite from Cdis 201 to Cdis 285 and 314

The motion passed.

On behalf of the EPC, Dr. Burger moved that grade estimates be due in the registrar's office on the 30th class day. Dr. Palombella moved to amend the motion to read "Grade estimates are due in the registrar's office on the 30th day of scheduled classes." The amendment was seconded and passed. The motion as amended passed.

Dr. Burger then moved, on behalf of the EPC, the following change to the wording in Goal 15 for General Education: Add the words "or minor" after the word "major" so the wording will read "Students who complete a required experience as part of their major or minor course of study are exempted from this goal." The motion passed.

Finally, Dr. Burger moved, on behalf of the EPC, that the Outcomes for Goal 3 of General Education be reworded as follows:

Understand major movements, themes, and values in one or more cultures as revealed in literature.

Analyze literary text as reflection of cultural movements, themes, and values

Develop and defend interpretation of literary texts through written discourse.

The motion passed.
