Approval of Minutes

On a motion by Mrs. Stallard and second by Mr. Gambill the minutes of the April 20, 1996 meeting were approved.

Business

Item 1 - Approval of Allocation From Reserve Funds

Mr. Hurley requested that the Board approve the President's request to allocate \$350,000 from auxiliary reserve funds for the South Ruffner, Tabb, and French renovation project.

(A copy of the request is file with "Addenda to Minutes of Meetings of the Board of Visitors" as Appendix 1, May 11, 1996.) Mr. Hurley reported that there is an estimated reserve fund balance of \$1,490,409 and stated that these funds are used to supplement costs for new construction, renovation, major repairs and equipment associated with the College's auxiliary buildings. On a motion by Mr. Slayton and seconded by Mrs. Russell the Board passed the President's recommendation.

Item 2 - Roy Clark Christmas Compact Disc (Information)

Mr. Hurley reviewed for information a proposal to record a Christmas compact disc (CD) with Roy Clark. He stated that the CD will utilize instrumentalists from Longwood and the Richmond area. The Longwood Camerata Singers will also be involved. Mr. Hurley reported that the College has been asked to provide funding in the amount of \$24,000 for the production of the CD. He stated that the sale of approximately 1,600 CD's would be the break even point for the College to recoup its initial investment.

Following a discussion about funding, Mr. Lacy recommended that Mr. Hurley request the Longwood Foundation Board to provide the funds for the production of the CD since the proceeds from the sale of the CD will be administered by the Foundation Board.

On a motion by Mr. Slayton and seconded by Mrs. Stallard the Board moved to go into Executive Session under Section 2.1-344 A1 and 3 of the Code of Virginia to discuss personnel matters and property acquisition.

The Board returned to open session. In compliance with the provisions of the Virginia Freedom of Information Act, a motion was made by Mr. Gambill and seconded by Mrs. Harwood to certify the discussion in Executive Session. BUSINESS AFFAIRS ACTION ITEM

REQUEST FOR FUNDS FROM AUXILIARY RESERVES

BACKGROUND: The College maintains an auxiliary fund balance called the Auxiliary Reserve Fund. These funds are maintained to cover costs associated with new construction, renovation, major repairs and equipment associated with our auxiliary buildings. The Board of Visitors approves requests for use of these funds. An allocation from reserve funds is needed to supplement funding previously allocated for the renovation of South Ruffner, Tabb and French.

As of June 30, 1996, the estimated uncommitted (available) reserve fund balance will be \$1,490,409.

ACTION REQUESTED: The Board of Visitors is requested to approve the President's recommendation that an allocation of \$350,000 be made from the College's auxiliary reserve fund for the South Ruffner, Tabb and French renovation project.
