From Dr. Arehart:

The motion to be presented to the Senate calls for eliminating Item 7 of the **H. Rank of Lecturer** on page 66 or the printed Faculty Manual 2004-2005 and on page 62 of the on-line PDF file of the Manual.

Specifically: eliminate item 7 and renumber Item 8 as Item 7, Item 9 as Item 8 and Item 10 as item 9

The amendment below will simply substitute its language for the current item 7 leaving current Items 8, 9, and 10 the same.

Substitute Amendment

The usual term for a lecturer does not exceed six years. In appropriate circumstances the Department Chair with the concurrence of the Department Promotion and Tenure Committee may request an exception to extend the term as lecturer. The request will be made by the end of September of the sixth year. By the middle of October the lecturer will supply a professional file to the Dean who would decide on the seventh year using all the criteria for tenure except those involving research and/or the terminal degree. The final decision is made by the VPAA.

A lecturer who is hired into his or her seventh year would expect a continuing yearly contract and may only be terminated under those rules that exist for a tenured faculty member (including post tenure review) or if a search

is conducted with the intention of hiring a tenure track faculty member. In the latter case, the lecturer must be given one year s notice that this will occur.
