Opening Faculty Meeting
August 26, 2005
Hiner 207

Dr. Hall called the meeting to order at 9:05 a.m. She called on Dr. Tracy who presented from the Executive Committee of the Senate a resolution that Longwood University faculty recognize and commend Dr. Frank Howe for his leadership as Faculty Senate chair for 3 years including 2 recent consecutive terms.

After generous applause, the faculty passed the motion without dissent.

Dr. Hall called for additions or corrections to the faculty meeting minutes of August 27, 2004, and March 31, 2005; the minutes were approved as distributed.

Dr. Hall opened the floor for nominations for faculty representative to the Board of Visitors. Dr. Brock-Servais nominated Dr. Craig Challender. Dr. Harbour moved that the nominations be closed. The motion was seconded and carried. Dr. Challender was elected.

In response to Dr. Hall's report about faculty action last spring nominating Dr. John Arehart as faculty representative to the Faculty Senate of Virginia, Dr. Brown moved that the nominations be closed. His motion was seconded and carried. Dr. Arehart was elected.

Dr. Kinzer for the Faculty Status Committee explained the committee's function of hearing faculty grievances, referred people to the section on the committee in the FPPM, and announced the membership for the coming year: continuing members Martha Cook, Ken Perkins, and Robert Webber (chair); new members Rená Koesler and Bill Harbour; alternates Jim Jordan, Jim Crowl, David Carkenord, Mc Amoss, Craig Challender.

Dr. Hall called on Dr. McWee, Vice President for Academic Affairs, who welcomed the faculty and thanked the departments who have borne with good grace inconveniences caused by minor disasters--sociology, psychology, and natural sciences. He spoke of an important focus for the year--our success rate as measured by retention. The Legislature's action granting three types of charter status to state institutions has imposed on the university 57 goals by which funding will be determined. Among those are:

1. entering class size--and Longwood's is down this year
2. progression from freshman to sophomore status--and our percentage while good nationally is down from last year's and is sixth in the state
3. degrees granted--and our senior class is smaller this year than last
4. the time it takes to earn a degree--and we do very well here at just over 4.5 years.

Dr. McWee asked the faculty to do four things to help in this endeavor:

1. Give mid-term estimates as required for all freshmen and all students earning grades under C (last year fewer than 50% of failing students had been given estimates).

Estimates alert academic support services to student needs. It wouldn't hurt to give estimates for all students.

2. Take attendance, especially in the first few weeks so that the class rosters you turn in to the registrar's office will be accurate.

3. Make contact with students whenever possible, especially in the first few weeks. Finding ways to engage them early is important and provides help that new students are reluctant to seek out themselves.

4. When referring students to other offices and services on campus, call ahead to make sure you are sending them to the right place. Too often students are sent to the wrong place for assistance.

Dr. McWee turned to the introduction of the new deans, Dr. Ross and Dr. Jones, and then called on Dr. Ross to introduce new faculty and chairs in the College of Arts and Sciences.
